Directions To Westerner Park

From the south: Take Highway 2 (Queen Elizabeth II) heading north. Take the exit onto Gaetz Avenue (City Centre). Continue to the right and exit onto 19 Street heading east. Follow 19 Street to the intersection of 19 Street and 46 Avenue. Turn right into the Westerner Park main north entrance.

IMPORTANT INFORMATION: Contestant packages will be available for pick up starting October 22, 2019 at the Donald Administration Building located at Westerner Park from the hours of 8:30 am to 4:30 pm Monday to Friday. If you do not arrive until the day of the trial, please stop at the Donald Administration Building located at the NORTH entrance beside the Campground. Upon arrival, you are required to pick up your package first, to ensure that you do not have to pay an admission fee or a parking fee to get onto the grounds.
